- The CDC and HRSA have issued guidance for development of a joint integrated HIV Prevention and Care Plan for 2017-2021. The integrated plan is due to HRSA by September 2016. The workgroup will have its first meeting on Monday Nov.23, 2016. Melissa Rodrigo is the Part A liaison for the workgroup.
- 3. The Part B monitoring site visit from HRSA was rescheduled for January 20<sup>th</sup> 22<sup>nd</sup>, 2016.
- 4. A handout reviewing the Part B overall income and expenses for the current year was reviewed.

Melissa Rodrigo reviewed Medical Transportation from 2011 through partial year of 2015 (Oct. 2015). The way services have been tracked has been relaxed to make it easier for services to be provided. There is one less provider for this service but more options for service have been added. Bryan Jones asked a question regarding para transit, Melissa Rodrigo states that the problem was resolved with RTA and the Grantee has it in writing from RTA. Providers were given the choice for this paratransit use, providers customize their transportation services to meet the needs of their clients. Gil asks about the loss of providers in the other county, Mellissa Rodrigo states those consumers are covered.

### **Planning Council Business**

#### a. HRSA site visit Feb. 2016

Myron reviews this; HRSA will sponsor additional Technical Assistance of Feb. 17-18, 2016. HRSA will provide TA on Feb. 17 and we will have an abbreviated Executive and PC meetings and a full date of HRSA Technical on Feb. 18<sup>th</sup>. Darryl Fore asked what the goal of this visit is. Sharron Harris explained that it is a continuation of TA request and Jan is available at this time. Sharron encouraged members to have questions ready for Jan when he is here, bring them to the January meeting and she will forward them to Jan and the HRSA Project Officer to allow Jan sufficient time to prepare answers for the TA session. Darryl asks about the Corrective Action Plan (CAP) follow up, Sharron states they will be checking on this progress as well.
