New/Old Business

a. Updating QI work plan – new HRSA requirements, new schedule, new approval, discuss monthly QI meetings proposal

- 1. Kate Burnett-Bruckman gave a presentation (handout was given) The HRSA Site visit was discussed. Per HRSA finding, all Standards of Care (SOC) need to be redone according to a new template; the first 6 will be this fiscal year.. Kate reviewed the minimal service standards components that are expected by HRSA. Next mtg in Sept.: preview the current language in the 6 standards that will be reviewed. Kate will email the slides & findings to the committee.
- 2. Julie Patterson presented 3 dates for SOC; 1) Oct. 7th -Medical Case Management & Early Intervention Services, 2) Oct.28th Substance Abuse Outpatient. & Mental Health, 3) Nov. 2 Oral Health & Food bank/Meals. They will be held at St. Augustine's and The Free Clinic.

- b. Grantee HIV Cross Part Care Continuum Collaborative (H4C) Presentation

- c. Grantee presentation of May CAREWare data request
 - 1. The committee had requested data on Quality Monitoring Outcomes for Medical Case Management, Oral Health Services, Mental Health Services, and Substance Abuse Outpatient Services (4 of the SOC to be updated this fiscal year). Kate Burnett-Bruckman presented these data in her power point presentation, starting on page 7. Kate also presented the Quarterly Review of the Cleveland TGA Treatment Cascade. Kate will email the full presentation to the committee. In the future, she will switch the locations of the "retained" and "prescribed" bars in the cascade, so as to have it more easily compared to the national cascade.
