## Review feedback from May 5 Community Forum – identify recommendations for PSRA Naimah was a little disappointed by the turn out, but pleased that there were new faces that attended.

Bryan was a little put off about the "Thank you" Sharron sent to Jen (specially the language that singled out Naimah and thanked her for you effort), he felt he wasn't given enough credit, when he was the one with the idea to team with Jen in the beginning when the committee was initially against the idea. He also felt the agenda was misleading of his role. Bryan also felt that Tammie Jones, or Melissa Federman should have been sending out emails to invite their clients to the community forum. Sharron Harris states that there needs to be an effective way at the front end to engage others to promote the forum. She urged the committee to do a more effective job developing the strategy to promote the event in the initial planning phase of the event.

Kimberlin Dennis states that there has been a lot of hard work that has gone into the planning, and trying to get the word out regarding the community forum. She feels this forum had a great turn out. There is a need for more diversity and have interpreters and literature in other language (Spanish). She found it interesting that there are people who do not know of Ryan White and that there is still a need to explain who and what Ryan White is about. Kimberlin encourages the guest to want to get involved and become a member. She states again that members need to step up and show up, get involved. She states that she feels that a great job was done by all that participated in the forum.

Sharron Harris reviewed the power point of the results from the community event. (See presentation). Sharron will circulate the power point presentation and post to the website. Sharron explains the need of the members to facilitate the discussion of the service categories and be able to explain them to other consumers.

Bryan Jones suggested a handout to give to consumers that explains the service category and who qualifies for it.
