New Business

- a. Needs Assessment update Center for Community Solutions
- Emily Campbell gave the report. The focus Needs Assessment for housing report is due
 February 28th. They have entered 51 surveys, a minimum of 100 was needed, and more are in hand. There were 13 completed online. The initial result findings, 12 indicated they had a homeless situation, 91% say housing is important to stay in care. It has mirrored the discussion that has taken place in the meetings. They have completed interviews with 8 organizations, 4 are scheduled and 4 need to be scheduled. They estimate that all counties will be covered. There is concern for the public housing waiting list which is extensive (Section 8), some lists are closed. Agencies that have been contacted for interviews are:
 Geauga Metro Housing Authority, Lake County Housing Task force, United Way, Community Action in Ashtabula, and Legal Aid Society covers several counties; Enterprise Community partners permanent supportive housing. Also, they are working on Medina Metropolitan Housing.

Kate Burnett-Bruckman reviewed the local Continuum of Care. She reviewed the handout, HIV diagnosis for TGA = 5,086, Part A clients = 2,842. Kate reviewed the cascade and what it means. The cascade shows the target population again as Black non-hispanic, and youth 13-24 and 25-44. Members should review this every quarter. Kate suggests that this would be a good data request. Jason will complete a data request for the grantee. Melissa Rodrigo states that anything unusual should drive a directive.
