**New Business** 

#### a. Needs Assessment update - Community Solutions, Tammie Jones

- Melissa Rodrigo reminded the committee of the process and timeline
- Emily Campbell presented; happy to work with Planning Council again on needs assessment
- Focus is on housing, they have gone live with a survey for those who have HIV/AIDS. 1. Surveys to consumers, open until Friday Feb. 10<sup>th</sup>. The Survey is available in hard copy at provider agencies and on line through Survey Monkey, 2. Key informant interviews of experts in HIV/AIDS and Housing fields also taking place, 15 or so people being interviewed through guided conversation. 3. Examine available funding sources and their limitations, Ryan White and HOPWA, what others could possibly partner. They are half-way through and will share the data as soon as it's available.
- Robert Watkins is working on housing for HIV/AIDS clients, they will teach consumers how to build houses from the ground up. Recovery Resources owns a 13-bed home located in East Cleveland. They are looking to repurpose the home. Consumers would have to have a dual diagnosis of mental illness and HIV/AIDS. Still in discussion phase within Recovery Resources, but community partners would be welcomed. Q. Long or short term? A. 1-2 years usual, they learn as they stay. Q. Gender specific or co-ed, A. this needs to be discussed further.
- Tammie Jones is not available for her Time study discussion.

## b. Non-Planning Council members – standing committee applications for QI
