- b. Grantee Quality Site Visit Presentation Kate Burnett-Bruckman Presentation was projected and handouts were given.

The presentation data is from Part A clients only. This data is important and may provide ideas for directives and PSRA. Most clients served fall within the 0-99% Federal Poverty Level (FPL). There was an increase in Part A clients between 301-500% FPL. 51% of Part A clients were receiving Medicaid and 18% had private insurance coverage. Possible update for transgender, those who are RW clients. Jason McMinn will complete a request for data sheet. Brian Jones feels that housing needs to be looked at in a different way. He feels that clients may not understand the housing question, since 82% of Part A client in CareWare indicated they had

The Grantee's office will provide updated demographics when requested.

Quality Outcomes - Over 80% is acceptable for monitoring visit – No corrective action, under 80% will receive a corrective action plan. OAMC- Improvements to most services, no corrective plans given. \*\*Dental and high risk percentages have dropped.

MCM data – no problems. Oral health – slight decrease in %.

Eligibility had a slight decrease between 2015/2016, due to the Affordable Care Act and Medicaid expansion.

Problem areas: Chlamydia, syphilis, oral health education, linked to med care was new. 2017 all service categories will be monitored for viral load suppression.
