### a. Grantee Review of the local Continuum of Care - Kate Burnett-Bruckman

The presentation was projected and reviewed for all in attendance
The format is new and Kate will take feedback as to if it should continue this way. Data shared is
from 2017. The total number of clients in the TGA is – 5,243, of that 3,095 received Part A
services. Kate reviewed data numbers for: linked to care, retained in care, ART, and Viral Load
suppression. Newly diagnosed number is 78 and of that, 62 were linked to medical care. (data is
from CAREWare) A data request was made for the break out of: linked to care, retained in care,
ART and Viral Load for those newly diagnosed. Robert Watkins agreed to prepare and submit a
data request form to make the formal request. QI approves of the new format; but they asked to
show raw data, do not use black to highlight, and to separate it out. Kate showed the last 3 years
of data – 2015-2017. Kate will email the presentation. Complete cascade report will be in May
2018.
