## **Meeting Minutes:**

# 1:30 – Welcome and Introductions

1:40 - Quality Improvement Project Updates - Zach Levar/Part A Funded Agencies

- Zach provided a PowerPoint presentation with each of funded agencies' AIM statements and viral suppression statistics for each agency's target population.
- Funded agencies each provided a summary of their efforts so far including their progress, strengths, and issues to date.



- Some barriers noted by providers:
  - Pharmacy access(medication adherence)
  - o Difficulty contacting clients
  - o Client commitment to care
  - Clients belief that they are well
  - o Clients do not have basic documents needed to be in medical care/have coverage
  - o Confidentiality/privacy
  - o IT barriers/internal delays
  - Substance abuse increase
  - o Long term clients- steady but not necessarily improving
  - o Staff turnover
  - o Insurance inconsistencies/communication
  - Narrow target population/had to expand from original plan
  - o Client's outside factors/personal barriers
  - o Transportation resources
- Some accomplishments noted by providers:
  - Medicaid expansion/more clients engaged in care
  - Clients identified expected barriers to care which were items agency was working on already
  - o Team meetings/case review
  - Intensive case management
  - Transportation resources
  - PAP's (Patient Assistance Programs)
  - o Communication with medical providers
  - o Increased daily/weekly communication
  - Mobile app/ access and expansion

#### 2:55 - Training - CQI Methods - Paul DeSario

- Paul DeSario of CCBH provided training to the CQM committee on various CQI tools that can help them in developing plans to carry out their AIM statements.
- Paul detailed and demonstrated 7 different CQI tools for providers using real life scenarios as well as clinical HIV scenarios. The tools demonstrated were:
  - o Affinity Chart
  - o Fishbone Diagram
  - Force field Analysis
  - o Flowchart
  - o Control chart
  - o Tree Diagram
  - o Prioritization Matrices
- Providers had back and forth with Paul regarding some of their CQI issues listed in the first portion of the meeting. Paul then plugged some of the issues into various CQI tools and walked the providers through the process.



## 3:45 – Positive Peers Smartphone App – Josh Kratz, MetroHealth

- Josh Kratz of MetroHealth demonstrated the new smartphone app that was created to help link youths living with HIV to medical care. With the use of a SPNS grant this app's main goals are to increase youth retention in medical care, lessen isolation and stigma, and for youth to better self-manage HIV which will lead to better health outcomes such as viral suppression.
- 4:00 UH CareLink Smartphone App Dr. Barb Gripshover, University Hospitals
  - Dr. Gripshover provided a summary of University Hospital's smartphone app, UH CareLink. This app helps patients take control of their own health by managing appointments, containing information about medications including dosage and frequency, and the usage of CareNotes that can contain notes from a physician.
