New/Old Business

a. Review Feedback from Consolidated Mini-Education Sessions

i. Plan Mini-Education next steps – The next steps discussion was moved to August, due to time limitations. Sharron Harris projected and reviewed the Powerpoint summary from all mini-sessions. James Stevenson inquired if community forums were a must; answer - according to Bylaws they just need to obtain consumer input for the PSRA process, but consumer input may come in multiple forms, including mini-outreach session.

Clinton Droster suggested that community forums be focused in the outlying counties since the mini sessions are working well in Cleveland.

Clinton also suggested to increase the consumer priority ranking from 6 to 8 for psychosocial, this increased the ranking % from 6.25 to 6.50. The group agrees to move Psycho social to #8 in order of Priority for the Priority Setting and move the other service down.

b. Update on Statewide Needs Assessment - did not address due to time limitation

c. **HIV Criminalization** - Naimah O'Neal wants to make HIV criminalization a topic for the mini sessions. Sharron wants to keep the mini session's topics service category related. Bryan Jones stated that it could be incorporated into the psychosocial service. The next meeting the committee will lay out the time line for more mini sessions and the topics. Bryan suggested that possibly have the CLC members talk to social workers about issues of primary concern to HIV+ clients, including educating Social workers on language that is often considered offensive to clients.
