#### **New Business**

Review & Finalize the specific Planning Council Service Delivery Guidance to be reported by Part A Funded Housing Staff

QI committee reviewed questions to be considered for Part A funded Housing Case Managers (CMs), QI co-chairs finalized the question with feedback from some QI members. QI co-chairs submitted the questions to the Grantee to be sent out to case managers. The Grantee reported they sent out questions to CMs this morning (Oct. 16), with deadline to provide the response for Nov 1<sup>st</sup>. Results from those questions will be presented to committee upon completion. The committee will tentatively look to set a meeting in January for case managers to attend and response to any questions as result of their finding. Attending upcoming meetings would be helpful in discussions.

**Question:** How far do you see us taking this discussion of housing?

**Response:** Perhaps just developing relationships is more important than discussing strategies, also establishing relationship with stakeholders of housing inventory to see how services can be improved in the housing areas.

**Question:** Will there be a needs assessment, at the October PAHA meeting based on current changes with HOPWA?

<u>Discuss potential of developing a Standard of Care for Housing</u> - Committee considered discussing this issue but tabled it due to because this is the role of the grantee and not Planning Council.

<u>Represent the TGA in Statewide Integrated Plan</u> - Committee meetings have been ongoing, but very few meeting offer conference call-in participation.

Presently, the committee is not clear on how to implement and/or coordinate efforts with the statewide integrated plan. Most activity takes place and documented in Columbus, which is not consumer participation friendly, also Part-A is not the lead in the plan. The Cuyahoga county component is headed by the City of Cleveland.

Q I Committee will work to be more active and refer to the state integrated plan at committee meetings. Co-chairs will also reach out to state-wide integrated plan representatives and report back to the committee.

Some work has been done on Data-to-Care Initiative (a data collection effort). This should be done by end of the year and the data from this should better inform and give more direction on how to implement the plan.

#### **Parking Lot Items**

Determine whether to review more funded services.

**Question:** Why was substance abuse no longer a funded service, it is so crucial for some PLWHA? **Response:** It was determined there were enough other providers/payers of this service such as Medicaid and the Alcohol, Drugs & Mental Health Services Board to pay for those services. Also Part A client utilization and spending has been very low for this service since there are other options available to clients for this service.

Comment: Keeping people informed is another reason why peer-led models are needed, to address real conversations on needs and accountability, such as gaps in oral health.
