#### New Business

<u>Review/Discuss Housing Report from Part A Funded Housing Staff -Determine Next Steps</u> Grantee reported that she received the responses today and had not had an opportunity to review it. There were five respondents to the survey. She provided a copy of the housing report to the QI co-chairs for review and the discussion.

The average caseload seems to be an average of 92 clients seen in a month. Top four needs: utilities, assistance with housing, eviction prevention and homelessness resources. Clients are utilizing all HOPWA services: specifically, legal and housing lists. Biggest referrals are HEAP (usually a three-month process) and Cleveland Housing Network. Barriers: affordable housing, temporary housing, and turnaround time such as: issuing checks to landlords for housing payments.

-Question: What about the City of Cleveland's efforts in housing? -Response: They want to assess the status and see what needs to be addressed which will take time.

apart, then you are classified in care. The newly diagnosed rate is 82% for clients received testing within 90 days of input into the database.

*Question*: For the low ranges of ages two to twelve, would that be due to uninformed parents? Is there any way to raise awareness on these numbers, and if so, is there a role planning council can play in helping to address the problem?

*Response:* It is an important point and perhaps a planning council member could attend the next continuum care meeting so they can provide an update to the committee.

*Comment:* The topic can be addressed at the next January meeting. Also consider utilizing patient advisory boards that may offer useful dialog in these issues.

## Represent TGA in Ohio Needs Assessment Process – V. Pannakal

Current updates include Ohio University (OU) is looking to expedite the approval process of their survey for year two. The approval of the survey is awaiting the Institutional Review Board (IRB) on Dec. 3<sup>rd</sup> and, if approved, the survey should go live soon after that time and be available online & in paper. PC will receive ongoing updates. They are also offering a \$15 gift card incentive to participants who take the survey. OU is also considering conducting an on-site visit to one specific agency, and doing one-on-one interviews in each region. Further information will be provided as it becomes available.

## Represent the TGA in Statewide Integrated Plan – C. Elrod

-The next Steering Committee meeting is set for 10:00 a.m. on January 17, 2020 at the Dept. of Natural Resources, 2045 Morse Road, Columbus, OH 43229. The current meeting objectives have been met and carried out, and there is further consideration on whether to add more activities in order to broaden those objectives.

Question: Are there barriers to services?

*Response:* There may be which would also make it difficult to get quality improvement data from clients who probably fall through the cracks due to barriers.
