- Sealed proposals must be submitted by Tuesday, February 4, 2020 at 11:00am

Proposal Requirements

Proposal Submission

- Proposals should be mailed or hand-delivered
- Submit one (1) original and five (5) copies
- Any proposal received after the time and date specified will be disqualified and returned unopened
- The official closing time will be determined by the time clock located in the CCBH Administrative Office – mail area

Proposal Requirements Cont'd.

Proposal Submission

- Vendors assume the risk of the method of dispatch chosen.
- CCBH assumes no responsibility for delays caused by any delivery service
- Postmarking by the due date will not substitute for actual proposal receipt
- Proposals may NOT be delivered by facsimile transmission, email or other telecommunication or electronic means.

Proposal Requirements

Cont'd.

- Pricing document provided in the proposal is to be completed by the bidder and must be signed by an individual authorized to enter into contractual obligations for the company.
- Respondent's Reference Sheet (Refer to Appendix 1-1)
- Non-Collusion Affidavit with signature and **must** be notarized (Refer to Appendix 1-2)

Proposal Requirements

Cont'd.

- Bid Guaranty – Required. (Refer to Section II.E.4)
 - Must be in the form of a bid bond for the full price of the bid

Or

 - Certified check, cashier's check or letter of credit for 10% of the bid amount

- Written Safety Plan

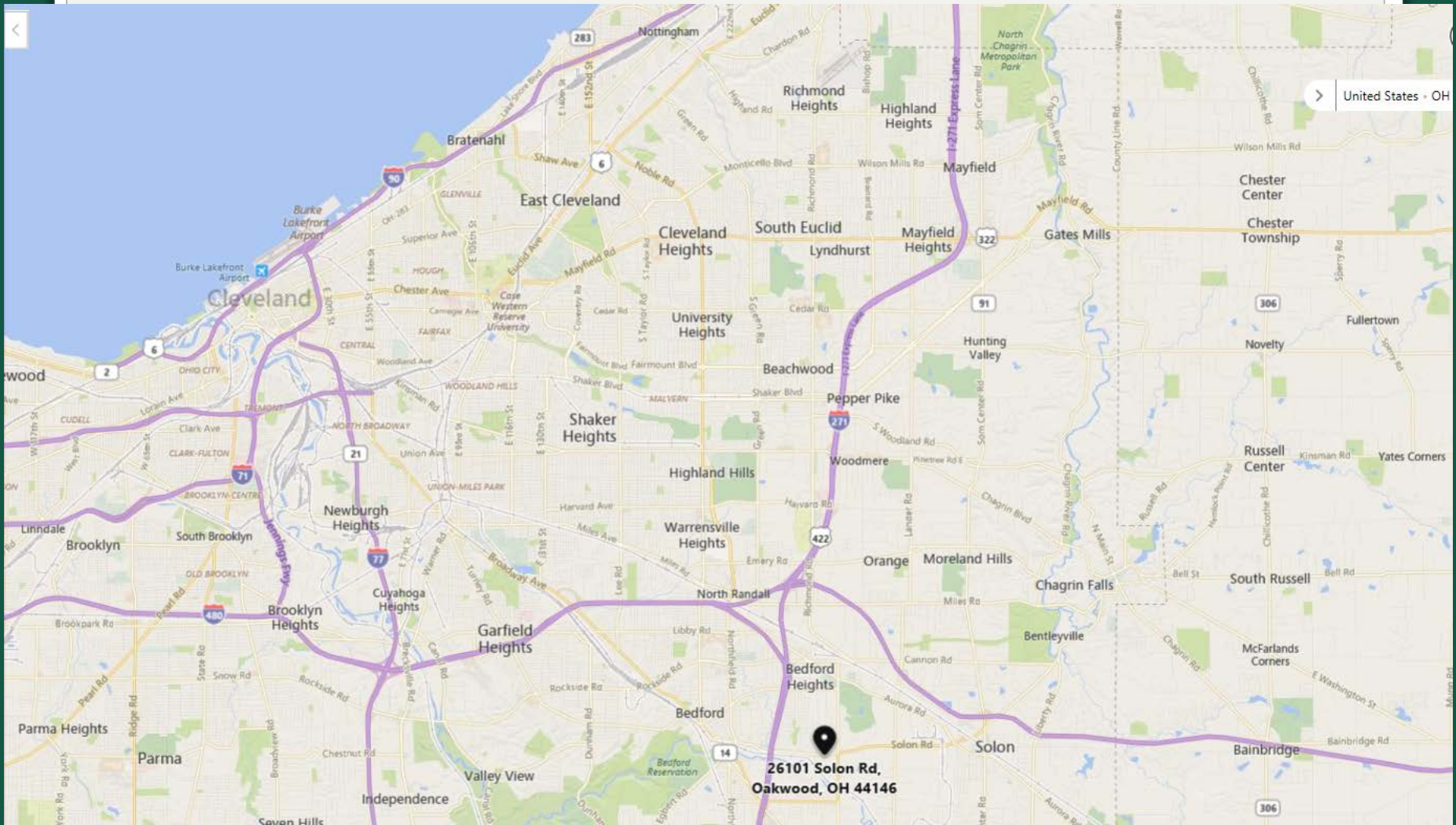
Additional Requirements

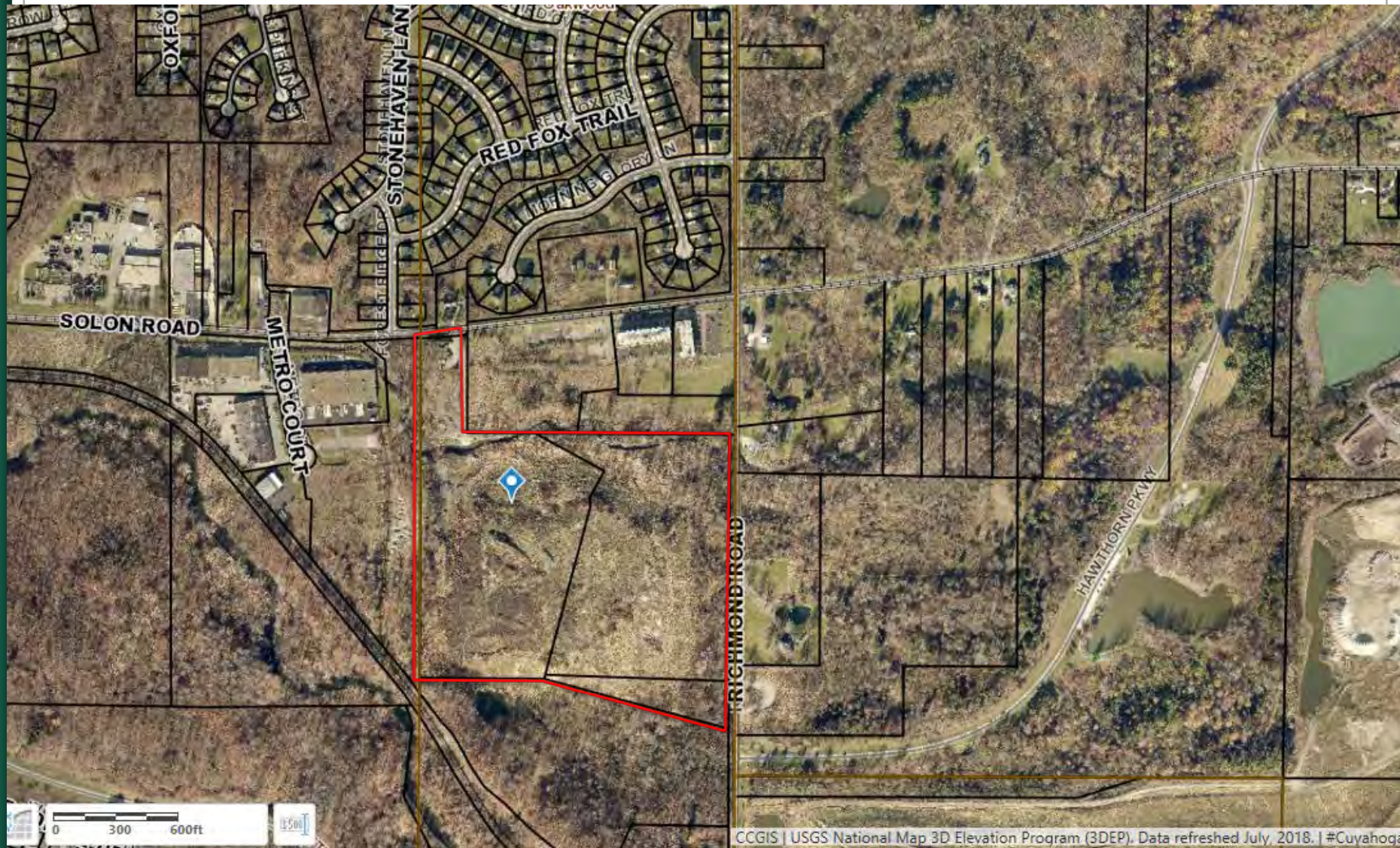
Cont'd.

- List of Equipment available for the project
- List of Subcontractors to be used (if applicable) and an explanation of their responsibilities
- Contingency Plan that addresses any delinquency in operating equipment or trained personnel

Notes

- A consistent 4:1 slope shall be maintained, starting at the toe of the slope to the top of the final elevation
- VAP Phase I Property Assessment and Limited Phase II Investigation will be provided upon request.
