Legislative Update – Sunshine Laws

Mr. Tom O'Donnell provided the Board with an update on the public meetings laws. Mr. O'Donnell advised that the Ohio Sunshine Law, ORC 121.22 requires appointed or elected members of a public body to be present to make a quorum and to vote. There are no exceptions. The Ohio legislature adopted ORC 5502.24 which permits government bodies to move meetings in times of emergency but it stops short of expressly allowing such bodies to meet virtually. Ohio Attorney General Yost published an opinion interpreting both statutes and concluded that virtual meetings are permissible in light of the current state of public health emergency so long as the public has access to attend and participate in the meeting.

It was moved by Mr. Gatt, seconded by Dr. Williams, that pursuant to Resolution 1993-43 and O.R.C. Sec 121.22 the Board Adjourn to Executive Session to discuss emergency matters.
