New/Old Business

Review Draft & Finalize Housing Survey for outlying counties

The committee reviewed and made final revisions to the housing survey for submission to the housing representative for feedback. The following are the comments, questions, and suggestions discussed.

- **1.** The committee initially approved questions one through five.
- **2.** For Question Number 6: *If you have housing, what was the length of time it took to get your housing?* The committee felt it best to change the timeframe to months rather than days, as it may appear clear to some but not to everybody.
- *Comment: R. Rolling -The clearer we are, the more people are inclined to agree with what you are getting across.
- *Comment: C. Barnett Also agree, as that was an issue at the September meeting. So, we want to be specific as possible.
- *Question: K. Dennis In considering days, what if a person was having housing problems for 30 days, or what if they couldn't get housing and it went on for months?
- 3. The committee was asked if anything more should be added to the form?
- *Comment: K. Dennis –Yes, a comment section can be added.
- *Comment/Questions: R. Watkins Money is important to housing, but there is nothing pertaining to resources for housing, so some questions could be: What are your resources for

payment, do you currently have resources available, or are you having difficulties with payments?

*Comment: R. Rolling -Maybe we could add the question as a yes or no then, please explain.

- **4.** For Question Number 3: Do you need housing assistance?
- *Comment: C. Droster We should be adding the resource issue to this question.
- *Comment: R. Watkins -The key word is financial assistance.
- *Question/Comment: T. Marbury Why not just say financial assistance or payment assistance so it encompasses whatever financial is needed? Also, just looking now at how long it will be, maybe some of the questions can go together so we don't end of having 99 questions.
- *Comment: B. Jones A lot of times people just don't get explained by case managers on these options for financial assistance.
- *Question: C. Barnett What about have you been referred to a housing case manager?
- *Comment: K. Dennis -Just add financial to Question 3, so it addresses financial and housing.
- *Comment: S. Harris Won't that make it awkward, though?
- *Comment: B. Gayheart -Maybe we could separate the two, one for financial, then one for access to a case manager, basically asking Question#3, if you have financial assistance needs, then a separate question, do you have a housing case manager, or do you understand what that is, becoming Question #4.
- **5.** For Question Number 10: Do you know your housing rights?
- *Comment: J. Mazo What does do you have housing mean? We all need assistance sometime down the line, but to be strong and having access to housing, we must have understanding of our rights, or otherwise we run into problems.
- *Comment: B. Jones So, looking at changing it to your rights as a tenant, few tenants know their rights, whereas most homeowners have a little more understanding of that, in general.
- *Comment: N O'Neal Housing rights relate to knowing your rights around your property lease or your rights as a tenant in a property?
- The committee agreed to change Question Number 10 to tenant's right and tenant's responsibilities.
- **6.** For Question Number 11: Do you have any additional questions? The committee initially thought to remove that, but additional comments suggested otherwise.
- *Comment: C. Droster Question Number 11 should include space for additional questions and information you would like to add.
- *Comment: N. O'Neal -We also need to create a resource guide to help people, as there are many things people are not aware of that are out there.
- *Comment: B. Jones There was an electronic and physical guide available in the past. It would help because some people you go to, or are referred to for help, can't help you.

A disclaimer will also be included so participants can know that the information they provide will be kept confidential and used solely for the purpose of creating a better housing plan.
