OBJECTIVES OF THE REQUEST FOR QUOTES:

The Cuyahoga County Board of Health is seeking to engage an executive search firm to conduct a national search for the next Health Commissioner for the Board, who will lead the Board's fiscal, administrative and programmatic activities in accordance with the Board's mission, vision, and values.

We seek to engage the search firm to complete the following objectives:

- Work with the Search Committee to develop a strategy, process and timeline to complete the search for a new Health Commissioner by November 30, 2021;
- Conduct meetings or phone calls with staff leaders and board to gain perspective on needed qualifications of prospective candidates;
- Provide the Search Committee with regular progress reports;
- Promote the opportunity in appropriate venues in through available communications methods to produce a diverse and robust candidate pool;
- Review applications for background and qualifications and prepare a written summary of the candidates with the most promising qualifications for review by the Search Committee;
- Assess candidates selected for serious consideration by the Search Committee by conducting in depth reference checks with individuals who are or have been in a position to evaluate the candidate's performance and personal attributes;
- Coordinate and participate in interviews with candidates;
- Verify selected candidate's educational background and conduct an appropriate background check in coordination with the Board of Health;
- Complete the selection by November 30, 2021;
- Notify declined applicants.

In the event that the selected candidate leaves employment with the Board before the period of one year, conduct an additional recruitment and selection process at no cost to the Board.

Organizational Information

CCBH is the local governmental public health authority for 58 communities serving a population of over 883,000 suburban Greater Cleveland residents with a mission to work in partnership with the community to protect and improve the health and well-being of everyone in Cuyahoga County. Our vision is to create the conditions in which all people who live, learn, work and play in Cuyahoga County have the opportunity to be healthy. CCBH's core values are health equity, integrity, partnership and innovation.

CCBH has an annual budget of approximately \$25 Million comprised of general revenue, grant and contract funds and employs a staff of approximately 160 full time staff 10-20 seasonal employees. CCBH programs and services are available on the website at **ccbh.net**.

- A quote, including proposed payment terms, for conducting this executive search, including all fees and charges associated with this process.
- A description of other services your firm offers in addition to executive search services.
- Three recent references from clients who are similar to CCBH (governmental and not-for-profit organizations).
- Disclosure of any relationships between your firm and any member of the board and/or staff of CCBH or a description of any other disclosures and/or conflicts.
