<u>Update on HIV Prevention & Care Integration</u>

We just finished the final edits on the bylaws, meeting tomorrow to go through update. Prevention is now incorporated into bylaws. The Prevention Committee representation on PC is twenty (20) percentage or seven (7) Prevention Committee members, while still maintaining a minimum of 33% representation unaffiliated PLWH on PC. HRSA encourages strong HIV Prevention & Care integration. However, the Prevention Committee will have no allocation authority, but will be a sounding board on whether a service is working well and if improvements are needed. Once the bylaws are voted on by a majority of the full Planning Council and approved, they will be posted to the website.
