New/Old Business

Open Nomination Close out

We completed recruiting for current grant year. There were six re-appointments, and eight new applicants for appointment. It was presented to Full PC last month, voted on, and docs are being put together for grantee who will forward to the Chief Elected Official in our 6-county jurisdiction, who is County Executive for formal appointment determination in accordance with Ryan White regulations. They will inform grantee on whether they will conduct interviews, of the applicants as they have done in prior years. They will contact applicants directly if interviews are requested. Last year the interviews were done virtually. They ask basic questions, similar to PC interviews. Also, in past years, they've asked Terry Allan to do a presentation to the committee about the Ryan White Program. We will keep everyone informed as they update us.

- B. Glass Look forward to new members considering serving on the MRM committee as your committee of Record.
- S. Harris Also got one new application from Ashtabula County. However, the application came after we had closed recruitment for this period, and the PC had voted on the slate of applicants, but we will follow up with her for next year's recruitment to keep them engaged.

Update on HIV Prevention & Care Integration

We have completed HIV Prevention & Care integration. Bylaws completed, added language and added Prevention Committee, added the committee update to the PC agenda. We are recruiting for co-chairs for CLC, MRM, and Prevention. Three people have expressed an interest in being a co-chair so far. The movement is happening, and we hope to have more individuals express and interest in being a co-chair. *Question: N. O'Neal – Do they have to be on a year for co-chair positions?

*Response: S. Harris – Not a full year, but most be an appointed member of the PC, they are encouraged to be a current member of the committee they wish to be appointed as the co-chair to better understand the committee's operations. The Bylaws outline the requirements for co-chairs. We will get back to the committee with more details.

*Comment: B. Glass – We hope we do find co-chairs soon, so we can effectively continue our work.

*Comment: S. Harris – Prevention committee attendees that were not appointed according to Ryan white regulations, can attend all meeting, but can only vote in the Prevention Committee. They cannot serve as co-chairs, in order to serve as a co-chair for any committee, you must be formally appointed in accordance with Ryan White regulations to serve on PC.

- *Question: C. Droster Do we need to address the bylaws term limit or be more in sync with HRSA?

 *Response: S. Harris Yes, there is a term limit issue to address. First, three years, followed by another three years (six years total), after you are required to roll off, then re-apply to return. We have to have at least 33% PLWH, unaffiliated with a Part A provider, if under that number we can hold PLWH to stay in compliance. We asked the positions in question, to allow for exemption. Part C and D are the concerns, because we only have two in our region that serve that category. We may have consumers

- *Question: C. Barnett If taking a break, can you still attend?
- *Response: S. Harris Yes, we just have to take you off the roster as an official member for a year, but you can continue to attend and just fill out a non-member form.
- *Comment: B. Glass we changes these to comply with HRSA at the time.
- *Question: K. Dennis What if a large group has to come out at the same time, most of us fall in that category.
- *Response: S. Harris That's where MRM comes into play. This will be the first time we'll be doing this for this changing cycle. If we don't get enough recruits, some can stay on until we can get replacements for mandatory membership categories.
- *Comment: B. Glass In light of crucial roles, they can stay until find others.
