Review Membership Roster for Term Limit Implications – S. Harris

There are no plans to roll off PC members slated for term limits before the June meeting. ***Question:** R. Watkins – What is the missing in criteria for recruiting, transgender, youth, etc.? ***Response:** S. Harris – There is no transgender representation on Planning Council, and we need more Latino representation. As for the transgender population, there is no data collected to measure the presence of that population in our region. The epidemiology data we use to measure the presence of HIV in our region is compiled by ODH. This data does not include the transgender population, but we do need to recruit locally because they are present in our TGA. We must do our best to make people feel comfortable and give them an opportunity to contribute.

*Comment: N. O'Neal – Maybe we should ask young people what they want to do and what they think is their place in this area, not as a token but as a real person sitting at the table.
*Comment: S. Harris – The challenge is finding out their issues so PC can explore them.
